# 簡介/ Introduction:

本課程旨在闡明神學的特殊性與處境性,進而突顯基督教傳統內部的多元性。本課程將探討各種神學觀點如何在特定的歷史與空間背景下產生。基於此一理解,本課程會展示,神學家並非僅僅吸收既有的神學,以應用於當代處境。相反,他們是在特定的時間、空間、文化、社會、政治及經濟現實所呈現的視域內,積極地「做」神學。此一過程包含著根據其當下處境重新詮釋基督教信仰傳統,並藉此使傳統得以活化。沿循此脈絡,本課程亦將嘗試探討「做」神學之實踐面向。

This course endeavors to illuminate the particularity and contextual nature of theology, thereby highlighting the plurality within the Christian traditions. It will explore how various theological perspectives emerge within specific historical and spatial contexts. Based on this understanding, the course posits that theologians are not merely assimilating pre-existing theologies for application to contemporary situations. Instead, they are actively "doing" theology within the horizons presented by specific temporal, spatial, cultural, social, political, and economic realities. This process involves reinterpreting Christian faith traditions in light of their immediate contexts, and in so doing, rendering the traditions living. Following this line of inquiry, the course will also attempt to discuss the practical dimensions inherent in the act of "doing" theology.

Students are expected to provide a thorough analysis of the chosen text, demonstrating their critical understanding of the material.

#### Organization and Structure (15%)

- Presents information in a logical, clear, and coherent manner.
- Uses a clear introduction, body, and conclusion to guide the reader.

#### Use of Evidence (10%)

- Supports assertions with evidence from the book and other scholarly sources.
- Integrates quotations and references effectively and appropriately.

# Writing Quality (10%)

- Uses clear, concise, and scholarly language appropriate for a theology course.
- Is free of grammatical and spelling errors.

# Formatting and References (5%)

• Adheres to proper formatting guidelines throughout the report.
